Jan sa endike nan Politik Èd Finansye pou Swen Sante (Financial Assistance Policy, FAP) Bon Secours Mercy Health lan, Bon Secours Mercy Health kalkile yon pousantaj AGB pou chak lopital Bon Secours Mercy Health baze sou metòd retwospeksyon an.

Konfòmman ak §1.501(r)-5(b)(3)(i), chak etablisman lopital Bon Secours Mercy Health kalkile pousantaj AGB li yo baze sou frè-pou-sèvis Medicare ak tout konpayi asirans sante prive ki peye etablisman lopital yo reklamasyon yo. Pou kalkile AGB pou chak lopital chak ane, yo divize sòm montan yo pou tout reklamasyon li yo pou swen ijans ak lòt swen ki nesèsè pou rezon medikal ke Medicare ak konpayi asirans komèsyal yo te otorize pandan yon peryòd 12 mwa anvan an pa sòm montan frè brit asosye pou reklamasyon sa yo. Pou 2022, peryòd 12 mwa yo itilize pou kalkil AGB chak etablisman lopital se te 1 Novanm 2020 – 31 oktòb 2021.

Yo te detèmine kalkil AGB a pou chak lopital. An relasyon avèk varyasyon prensipal frè a ak to kontra swen jere yo, kalkil AGB yo pou lopital yo te varye ant 12% ak 50%. Apati 1ye Mas 2022, Bon Secours Mercy Health te etabli yon pousantaj AGB rejyonal pou frè brit ki aplikab pou tout etablisman lopital yo nan rejyon an baze sou pousantaj AGB ki te bay pi gwo rabè a nan chak rejyon.
